Conditions/Rules – Please read Carefully.

- All Runners to assemble at running of Cutter Statue at 3.00 p.m. promptly.
- All runners must follow the directions of Cutter officials.
- All Runners must follow instructions of Traffic controllers.
- All Runners must carry a billy.
- Runners can only run ONE leg of the race.
- Spillage is to be kept to a minimum.
- There is to be no jostling of other runners.

Race Route

- The race will start and finish at the “Cutter” Statue. All team members must be present at the Cutter Statue at the completion of the race.
- Runners must assemble at the statue at 3.00 p.m. to hear rules and conditions of entry. Team members will be transported to each hotel. (Except runners for the Grand and Leichhardt). ALL runners must start and finish at their designated points as follows.
- RUNNER 1 will leave from the statue and cross the highway at the former Commonwealth Bank corner and proceed along the footpath to the Golden Nugget Hotel.
- RUNNER 2 will be leaving the Golden Nugget and will follow the same route and run up the footpath on the school side of Morgan Street to the Leichhardt Hotel.
- RUNNER 3 will be leaving the Leichhardt and will travel down the footpath on the school side of Morgan Street to the Grand Hotel, using designated crossing.
- RUNNER 4 will leave the Grand Hotel and run along the Grand Hotel side of Central and James Street footpath to the Railway hotel.
- RUNNER 5 will leave the Railway Hotel and return along the same route and will cross over at the High School intersection and run along the footpath adjacent to the IGA to the Running of the Cutter Statue in Morgan Street.
- RUNNER 6 (The Drinker) must drink a 700ml bottle of beer/non-alcoholic beer from a billy prior to winners being declared. With minimal spillage, the judges’ decision will be final regarding acceptable spillage
